Sub: Consolidated Scrutinizer's Report on remote E-voting and E-voting at the 38th Annual General Meeting (AGM) of M/s. Vistar Amar Limited held on Tuesday, 13th September, 2022 at 03:00 p.m. (IST) through Video Conference ("VC")/ Other Audio Visual Means ("OAVM")

Dear Sir,

- 1) I, Isha Sumit Gupta, Proprietor of M/s. I S Gupta & Co., Practicing Company Secretaries, have been appointed as the Scrutinizer by the Board of Directors of Vistar Amar Limited ("the Company") at their Meeting held on 10th August, 2022 for the purpose of scrutinizing the remote e-voting process (i.e., voting remotely, before the AGM, using an electronic voting system) held from Saturday 10th September, 2022 at 10:00 a.m. (IST) to Monday 12th September, 2022 at 05:00 p.m. (IST) under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and subject to Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) regulations, 2015, in respect of Resolutions set out in the notice dated 10th August, 2022 ("Notice") of the 38th Annual General Meeting (AGM) of the Members of the Company held on Tuesday 13th September, 2022 at 03:00 p.m. IST through Video Conference ("VC") / Other Audio Visual Means ("OAVM").
- 2) I am also appointed as the Scrutinizer to scrutinize the e-voting process during the AGM (process of e-voting at the AGM through electronic voting system).
- 3) The Notice dated 10th August, 2022 convening 38th Annual General Meeting (AGM) of the Members of the Company alongwith the Statement setting out material facts under Section 102 of the Companies Act, 2013 were sent to the Shareholders in respect of the below mentioned resolutions as passed at the said Annual General Meeting of the Company held on Tuesday 13th September, 2022 at 03:00 p.m. (IST) through VC / OAVM. The emails



were sent in compliance with the General Circular nos. 20/2020 dated 05th May, 2020, 02/2021 dated 13th January, 2021, 19/2021 dated 08th December, 2021, 21/2021 dated 14th December, 2021 and 02/2022 dated 05th May, 2022 issued by the Ministry of Corporate Affairs ("MCA") and Circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/79 and SEBI/HO/CFD/CMD2/CIR/P/2021/11 issued by the SEBI (hereinafter collectively referred to as "the Circulars")

- 4) The Company has availed the e-voting facility offered by e-voting platform/ system provided by the Central Depository Services (India) Limited (CDSL), the agency engaged by the Company to provide e-voting facility for voting through electronic means.
- 5) The Management of the Company is responsible to ensure the Compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic modes on the resolutions proposed in the Notice of 38th Annual General Meeting of the Members of the Company dated 10th August, 2022. My responsibility as a Scrutinizer for the e-voting process (i.e., through remote e-voting and e-voting during AGM) is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolutions proposed in the Notice of the AGM of the Company, based on the report generated from the e-voting system provided by CDSL and the documents furnished to me electronically for my verification.
- 6) The Members holding Equity shares as on the "cut-off date" i.e. 06th September, 2022 were entitled to vote on the proposed resolutions as set out in Item Nos. 1 to 6 in the Notice of AGM of M/s. Vistar Amar Limited.
- 7) The remote e-voting facility was kept open from Saturday 10th September, 2022 at 10:00 a.m. IST till Monday 12th September, 2022, 05:00 pm. IST and the CDSL e-voting platform was blocked thereafter. The Company had also provided e-voting facility to the Members present/ logged-in at the AGM through VC / OAVM and who had not cast their vote earlier and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the resolution on the e-voting platform provided by CDSL.
- 8) After the time fixed for closing of the e-voting by the Chairman, the electronic system recording the e-voting was locked by CDSL.
- 9) The votes casted under e-voting facility were then unblocked on Tuesday, 13th September, 2022 after the conclusion of the AGM in the presence of two witnesses not being in the employment of the Company as prescribed under sub-rule 4(xii) of Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time.
- 10) Thereafter, the details containing, inter alia, the list of Equity Shareholders who voted "in favour" or "against" on each of the resolutions that was put to vote, were generated from the e-voting website of CDSL, i.e., <https://evotingindia.com>. Based on the report generated by CDSL, scrutinized on test check basis and relied upon by me.


